John was an accomplished and very well respected practitioner who was passionate about the future of Guernsey's International Insurance Sector. During his career he also served as a Commissioner of the Guernsey Financial Services Commission. John's legacy is carried forward with sections of his original text recreated here by kind permission of Key Haven and the Parkinson family, whose co-operation and support is greatly appreciated.
