Industry and the Members

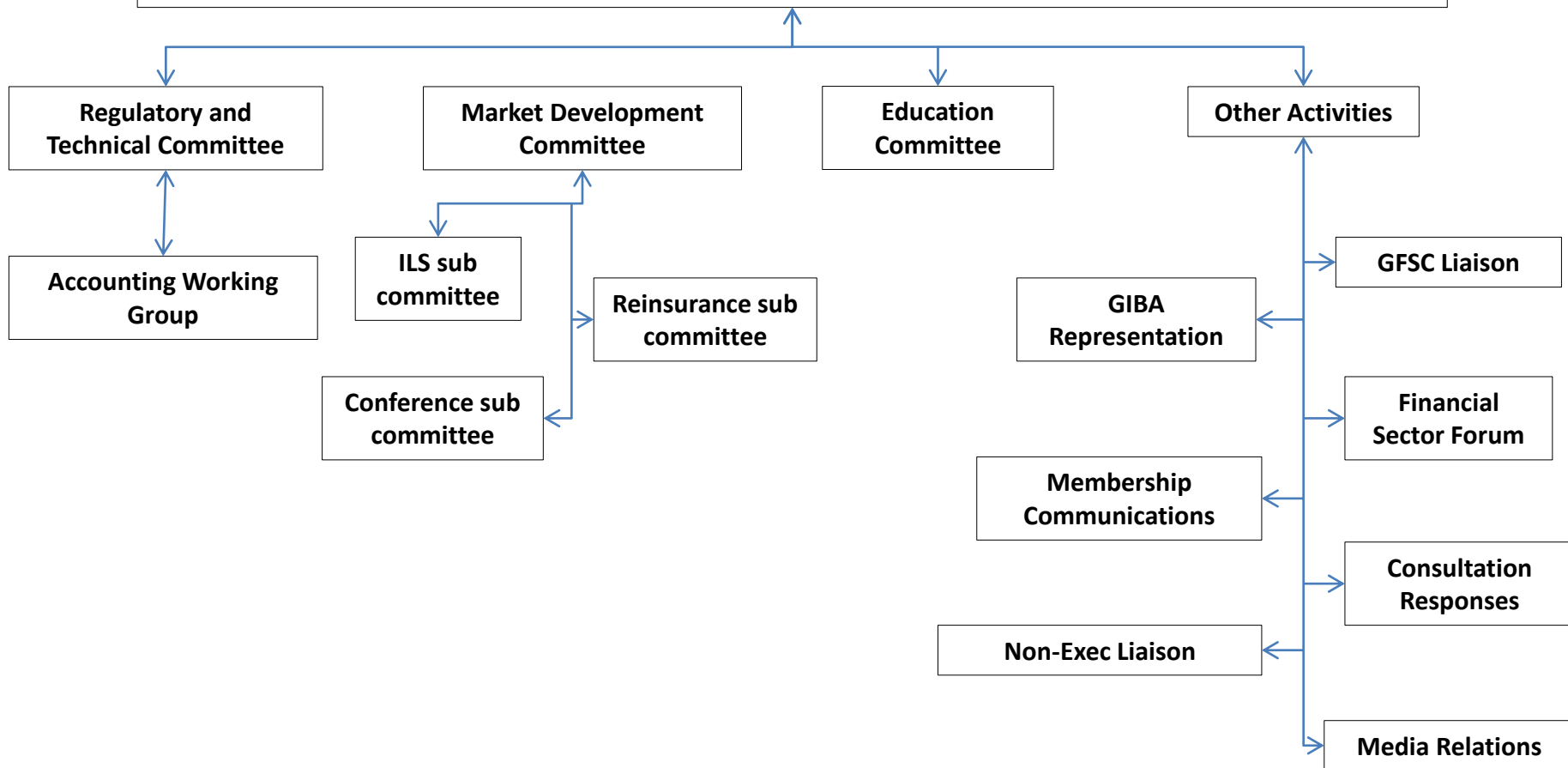
